**Tapestry Music Rental Terms and Conditions** 

## **Band & Strings**

This Document constitutes a contract between Tapestry Music Ltd. and the signator (Lessee) and is subject to the following terms and conditions:

- 1.) Title and ownership of the instrument stated on the rental agreement will remain with Tapestry Music Ltd. until all rental payments received equal the Rent To Own price as stated on Appendix A. and or B. of this document, or when the contract is bought out.
- 2B.) Band Instrument Rentals: 100% of all payments received may be applied to the Rent to Own Price as stated on Appendix A. and or B. In the case of the Lessee wishing to buy out this contract before the end of its term, Tapestry Music Ltd. will offer a 25% discount on the balance owing after all principal payments are taken into consideration and if the Lessee account is current and in good standing. Taxes and insurance/maintanace costs do not apply. The title of the instrument will transfer to the Lessee and this contract will be considered cancelled. String Instrument Rentals (including violins, violas, cellos and double basses). 50% of all principal payments received may be applied to the Rent to Own Price as stated on Appendix A. and or B. Taxes and insurance/maintanace costs do not apply. In the case of the Lessee wishing to buy out this contract before the end of its term, Tapestry Music Ltd. will offer a 25% discount on the balance owing after all payments are taken into consideration and if the Lessee account is current and in good standing. The title of the instrument will transfer to the Lessee and this contract will be considered cancelled. Smaller fractional size string rentals:
- 3.) A credit card (Visa, MasterCard, Amex) is required for all rental contracts. One spouse must be employed and a daytime work number must be provided. The Lessee agrees to inform Tapestry Music Ltd. of any changes to this contract, including change of address, phone number or credit card information. Failure to inform Tapestry Music Ltd. within 60 days of such changes will constitute a breach of contract and result in a demand for the return of the instrument.
- 4.) If more than one rental contract is held by the Lessee for other instruments only the payments received for the instrument as stated on Appendix A. and or B. of this contract are applicable to purchase. This contract is not transferable.

#### 5.) MONTHLY RENTALS

• a) The minimum rental period for all used instruments is three (3) months. Payments are due for each subsequent month by Visa, MasterCard or American Express or by post-dated cheques.

- b) Credit Card information of the Lessee must be supplied as security regardless of payment option chosen.
- c) Past Due Accounts: The Lessee agrees to pay a \$15 late fee each month in addition to the rental payment until the account is brought up to date and is in good standing. Accounts past due for more than ninety (90) days will result in the forfeit of all payments and the full rent to own price as stated on page 3/4 of this document will be due and payable.
- d) A \$15 service charge is applicable to any NSF or returned cheque.
- e) In the event of a cheque being returned NSF, the Lessee authorizes Tapestry Music Ltd. to charge the credit card supplied for the fast amount of the returned cheque plus a \$15 service charge unless arrangements have been made satisfactory to Tapestry Music Ltd.
- f) The Lessee is responsible for informing Tapestry Music Ltd. of any changes to address, phone number, post dated cheques and credit card information, including expiry date.

#### 6.) YEARLY RENTALS

- a) School year rentals cover the 10 month period of September to June 30th. There is a (6) month minimum on new instruments, and a (3) month minimum on used instruments. The instrument must be renewed, bought out or returned by June 30th.
- b) If the instrument has not been renewed or returned by June 30th, the Lessee acknowledged that this agreement will be continued and authorizes Tapestry Music Ltd. to charge their credit card at the yearly rate and insurance (if applicable) as stated on the page 3/4 of this document on July 15th.
- c) If the Lessee returns the instrument after June 30th and a yearly payment has been charged, the yearly payment will be refunded less the corresponding monthly rate for each month the instrument is kept. 1 Tapestry Music Rental Terms and Conditions
- d) If for any reason a yearly payment cannot be charged to the Lessee credit card after July 15th, a 15% (based on the principal year rate) late fee is payable July 15th and on the 1st of each subsequent month until the instrument is returned.
- e) Failure to contact Tapestry Music within 30 days of the expiration on June 30th with a

form of payment or return of instrument will result in the demand for return of the instrument. Accounts past due for more than ninety (90) days will result in the forfeit of all payments and the full rent to own price as stated on Appendix A. and or B. will be due and payable.

## 7.) INSURANCE:

- a) Insurance is optional and covers accidental damage, theft and fire.
- b) Insurance does not cover loss, abuse or neglect. Repeated damage, cases being sat on or dragged on the ground will void insurance.
- c) Determination of the cause of damage will be made solely by Tapestry Music Ltd.
- d) Insurance is invalid if instrument is taken outside of British Columbia.
- e) If the instrument is stolen, the Lessee must provide a copy of a police report or file number as to the circumstance of the theft.
- f) If the instrument is damaged beyond repair, the instrument must be returned to Tapestry Music for evaluation and determination of the insurance claim.
- g) For damage beyond repair or a theft claim, a deductible of 20% of the value of the "Rent To Own Price" at the time the rental was issued shall be paid by the Lessee to replace the instrument with another instrument of equal value and age.
- h) Insurance rates: \$3.00 monthly Flute, Clarinet Trumpet, Trombone, Guitar, Bass Guitar, Snare Drum, Bell Kit, Violin \$5.00 monthly Saxophone, French Horn, Euphonium/Baritone, Bass Clarinet, Oboe, Cello, Keyboard, Digital Piano, Double Bass i) If the Lessee has not paid for insurance and the instrument if returned at the end of the rental period is deemed damaged by a technician, the Lessee agrees to pay 10 months worth of the insurance rate (\$30 or \$50) to cover repair costs. Tapestry Music reserves the right of inspection and charge up to three months after return.
- j) Insurance is not available on effects pedal rentals.
- 8.) The payment is non-refundable. Yearly rates will be pro-rated to the monthly rate and balance refunded. The Lessee will remain responsible for any overdue payments, damage if any, and missing accessory items issues at the time of rental until a return receipt is issued.
- 9.) Instruments left at the Lessee's school will not be considered returned until the instrument is physically returned to Tapestry Music Ltd. and a return receipt has been issued to the Lessee. The Lessee is responsible for all payments plus damage or charges, if

any, until these conditions have been met. DO NOT LEAVE INSTRUMENTS AT SCHOOL unless arrangements have been made between the music teacher and Tapestry Music.

- 10.) The Lessee acknowledged that the instrument was received with all accessories (mouthpiece, cleaning supplies) on the date of this contract.
- 11.) In the event of theft, loss or damage beyond repair, the Lessee assumes all responsibility for the full balance owing and will pay Tapestry Music Ltd. for same, unless the Lessee holds insurance (see #7).
- 12.) The lessee acknowledges that any changes in Provincial or Federal sales tax (PST, GST) will be reflected on payments.
- 13.) PAST DUE ACCOUNTS: If for any reason this agreement is past due over 90 days, Tapestry Music Ltd. reserves the right to demand the return of the rented instrument with any past due rent and penalties payable. Accounts past due for more than ninety (90) days will result in the forfeit of all payments and the full rent to own price as stated on the on page 3/4 will be due and payable. Please keep your contact and financial information current to avoid this action.

Lessee may terminate this contract by returning the instrument to Tapestry Music Ltd.

- 14.) Tapestry Music Ltd. will allow for instruments to be exchanged on this contract. If during the rental period the instrument is exchanged, all rental payments that have accrued may be transferred as rental credit to a second instrument of equal or greater value. In the case of an instrument being exchanged for another instrument of lesser value, a pro-rated rental credit will be given at the lower monthly rate. Exchange credit is only issued for accounts in good standing and if the rental period is uninterrupted.
- 15.) The instrument on this contract is covered by warranty from manufacturer defects for the duration of the rental period. All repairs or warranty servicing must be provided by Tapestry Music Ltd. Warranty does not cover strings, reeds, pads, damage, neglect, theft or loss.

#### **Tapestry Music Ltd. - Effects Pedal Rental Terms and Conditions**

Thank you for choosing Tapestry Music Ltd. for your effects pedal rental needs. Please carefully review the following terms and conditions before proceeding with your rental agreement:

- 1. **Rental Agreement:** By renting an effects pedal from Tapestry Music Ltd., you agree to abide by the terms and conditions outlined herein.
- 2. **Rental Period:** Effects pedals are available for rent on a weekly or monthly basis, as specified by the Lessee at the time of rental.
- 3. **Rental Payment:** Rental payments are due in advance for each rental period chosen. Payment options include weekly or monthly payments. The first payment is due at the time of rental and subsequent payments are due on the same day of each subsequent rental period.
- 4. **Purchase Option:** Should the Lessee wish to purchase the effects pedal they are renting, they may apply their rental payments towards the purchase price within the first 30 days of the rental period. After this initial 30-day period, rental payments cannot be applied towards the purchase price.
- 5. **Security Deposit:** Credit card information of the Lessee must be provided as security regardless of the chosen payment option. The credit card will be charged for any outstanding rental fees, late fees, or charges for damaged or lost equipment.
- 6. **Late Fees:** In the event that the Lessee fails to return the effects pedal by the effective due date, a late fee of \$15 will be charged for each month the rental remains outstanding, in addition to the rental payment. Late fees will continue to accrue until the account is brought up to date and is in good standing.
- 7. **Past Due Accounts:** Accounts that are past due for more than ninety (60) days will result in the Lessee being charged the full new price of the effects pedal, in addition to any applicable late fees. Tapestry Music Ltd. reserves the right to pursue legal action to recover outstanding amounts owed.
- 8. **Condition of Equipment:** The Lessee agrees to return the effects pedal in the same condition as it was received, normal wear and tear excepted. No velcro or adhesives shall be on the pedal. Pedals must include their original box and packaging upon return. Any damage beyond normal wear and tear will be assessed and may result in additional charges to the Lessee.

- 9. **Cancellation:** Rental agreements may be cancelled by providing written notice to Tapestry Music Ltd. at least 48 hours prior to the end of the current rental period. No refunds will be provided for early returns.
- 10. **Governing Law:** These terms and conditions shall be governed by and construed in accordance with the laws of British Columbia, Canada, without regard to its conflict of law provisions.

By proceeding with the rental agreement, the Lessee acknowledges that they have read, understood, and agree to abide by these terms and conditions. Tapestry Music Ltd. reserves the right to amend these terms and conditions at any time without prior notice.
